State Spotlights: Doubling Down on Outreach for Postsecondary Transitions



In a time when transitioning from high school to higher education is especially challenging, one critical way to prevent a "Lost COVID Cohort" is to make sure the value of higher education for longterm economic success is effectively communicated to students. It can be difficult to break through the noise, but several states are doubling down on innovative ways to reach students and ensure they know how important it is to pursue postsecondary education — and that they are welcome at higher education institutions.

Kentucky has initiated a <u>FAF\$A for the Future TikTok Challenge</u>, led by The Kentucky Council on Postsecondary Education and GEAR UP Kentucky, to help raise awareness of the importance of completing the FAFSA. The challenge encourages high school principals and superintendents in the Commonwealth to get creative and post videos on the popular social media app – all to help educate students about the FAFSA process and urge them to apply.

Last summer, higher education partners across *Tennessee* launched the <u>It's Go Time TN campaign</u>, which aimed to support and encourage recent high school graduates and returning students who had not yet finalized their college-going plans to do so quickly. The campaign included a website and a social media push through Twitter and Instagram to connect students with information and resources to support their postsecondary transitions.


In *Texas*, college access organizations banded together to launch <u>Future Focused TX</u>, an initiative to help maintain college enrollment rates in Texas despite COVID-19. The campaign provides free, compelling, research-based digital content to school counselors to help students graduate and matriculate into college.

Without Limits: A Shared Vision for the Future of Career Technical Education from AdvanceCTE



The Road to Readiness: Pathways to Success After High School



A new <u>report</u> from the Alliance for Excellent Education analyzes college and career readiness policies (including high school graduation requirements) across all 50 states and makes recommendations for how to strengthen them to ensure all students graduate ready for success. The report finds that 29 states currently offer multiple pathways to a diploma, providing students with options regarding the high school experiences they

will have and, often, the postsecondary experiences for which they will be prepared. However, students in 13 states choose between a college-preparatory pathway and a career pathway—a choice that may limit the options available to them after high school.
